As allowed by executive order of the Governor of Massachusetts, in compliance with the provisions of Massachusetts General Laws, Chapter 30 and 15A, Section 9, and with a quorum present in-person and via audio/video-conference, the Academic Affairs Committee of the Board of Trustees of December 11, 2024, with Committee Chair Keator presiding was called to order at 8:31 a.m.

In reference to last meeting of the committee that was cancelled, the faculty applying for tenure will present. The Peer Institutions conversation will be held at a future meeting.

#### Accreditation and Program Reviews

Provost Glejzer provided a review of the recent NECHE 10 year accreditation visit as well as the JCERT Nursing program visit. NECHE singled out the success in assessment and program reviews of MCLA. There was some initial skepticism about a nursing program at a liberal arts college, however by the end the team was pleased with how the liberal arts supported and rounded out the

curriculum. We will get a final report soon. Aside from one minor website communications issue, all other areas passed.

There was discussion on our success versus a tech school. Provost Glejzer noted that we have 100% placement and JCERT exam passing. When looking at the institution, students come in knowing they will have credentials for doing work beyond the technical.

There was further discussion that the program is near full capacity before requiring additional hires capacity in program. Student Athletes also find the program valuable.

Provost Glejzer noted the Political Science Program review and Community Health program review were also recently completed. Poli-Sci reviewers recommend more internship capacity, and overall report was positive.

The Education program was also recently reviewed by DESE and we received full approval without any outstanding items to address.

All these visits were helpful for a review of current practices and future changes.

# **Faculty Incentive Awards**

Provost Glejzer detailed the awarding of Faculty Incentive Awards to support research and development. The awards are donor-funded through the Foundation. They are awarded by previous faculty awardees. There was discussion of the awards process and how the college works to be fair and equitable in their process while maintaining faculty input. Academic Affairs is the final arbiter, working in tandem with the committee and can intervene as needed.

# Sabbatical Applications 25/26

Provost Glejzer then detailed the applications for sabbaticals as well as the requirements to apply. There was discussion of how to share the research back with the Trustees which may include presentations at future meetings.

Professor David Eve's application is not being approved as both faculty in comp sci asked for sabbatical. David volunteered to withdraw his sabbatical. Dean Dehner has applied as well.

There was discussion of coverage for classes. In some cases when there is a full year we do need to hire an adjunct to cover. The Provost is not concerned with the current coverage needs.

Provost Glejzer noted that they will work on the form to make it clear what the work will be, He is proud of this body of requests and it is exciting to see this work from our faculty. They connect back to their teaching in every instance, and we see the influence of the liberal arts in all of the applications.

There was discussion of the Professors retaining intellectual property rights for the work they create while on sabbatical. They may write books or create other products. The expectation for earnings from the projects is low. We are mindful that the line is clear between work and college work.

Provost Glejzer provided a review of the faculty members who have applied for sabbaticals in 2025/2026.
