#### TUITION EQUITY PROGRAM FOR NON-U.S. CITIZENS

Massachusetts has now expanded eligibility for in-state tuition to students who have attended Massachusetts high schools for at least three years and earned a Massachusetts high school diploma.

This expansion will ensure that many non-U.S. citizens are able to access in-state tuition and state financial aid programs. Students interested in this program must apply by first completing a *Tuition Equity Eligibility Form and Affidavit for High School Completers*. This form can be found on <u>Mass.edu/TuitionEquity</u>.

### DON'T WAIT -2024-2025 FAFSA NOW AVAILABLE!

Have you applied for aid for next year? The new, simplified FAFSA is now available! Complete the FAFSA today on <u>StudentAid.gov</u>.

On December 30, the Department of Education soft-launched the new, simplified FAFSA form. This streamlined application will make applying for aid easier than ever.

Don't wait to apply for aid. <u>The priority</u> <u>deadline for financial aid is March 1.</u> <u>2024.</u> Students can complete their FAFSA after this date, but funds are awarded on a first come, first serve basis.

## REFUNDS FOR SPRING 2024

If your financial aid or payments exceed your charges, you will be issued a refund. Refunds occur throughout the semester as funds disburse. MCLA will deliver most student refunds electronically through BankMobile Disbursements. Not enrolled in BankMobile? It's not too late! Learn more at Ink.mcla.edu/refunds.

Most student refunds will be disbursed in mid-March. Some refunds may disburse before or after, or in partial amounts.

### STUDENT LOAN REPAYMENT FOR GRADUATING SENIORS

If you are graduating/leaving MCLA and are a federal student loan borrower, your loans will be entering repayment. You will be contacted by the Office of Student Financial Services in April about completing online Exit Counseling.

## SUMMER FINANCIAL

### WITHDRAWING FROM MCLA?

Are you thinking of withdrawing fully or taking a leave of absence mid-semester? Prorated refunds occur up until the 60% point of the semester. The final date for proration is **3/17/2024**. (Prorations will not occur after this date and this deadline is separate from the course withdrawal deadline.) Our college refund policy is at Ink.mcla.edu/refundpolicy.

Are you withdrawing from only one class? Withdrawing from one class will give you a grade of a 'W' and no refund occurs. Please check with Student Financial Services to see how this may affect your academic progress for financial aid.

#### SATISFACTORY ACADEMIC PROGRESS

The <u>Satisfactory Academic Progress</u> (SAP) Standard is used for continued financial aid eligibility. *Commitment Scholarship recipients must also be making satisfactory academic progress to renew their award.* This standard factors in GPA and credits earned. #### ANNUAL LOAN BORROWING NOTICES
