Good afternoon -

May 29 marked a new era with the lifting of all the Commonwealth's COVID-19 related mitigation measures. As we transition into a new normal and begin to operate in a less restrictive environment, we will remain vigilant and continue to monitor available public health data, while making decisions that keep our community safe and progressing to a place of more togetherness.

More detailed communication will follow later this month sharing how MCLA will adapt to post-pandemic operations with a full return to the classroom and residence halls for the fall 2021 semester. This communication is to address the most pressing issues impacting employees and offer some reminders.

# Campus Mask Protocol Lifted

In step with the Baker Administration's lifting of all COVID-19 restrictions in the Commonwealth, effective immediately, MCLA's mask requirements in all campus settings are removed. We encourage all unvaccinated employees to follow the public health advisory issued by the MA DPH on May 29 that "advises all unvaccinated residents to continue to wear masks in indoor settings when they can't socially distance". Each of us feels differently about mask wearing; some of us are hesitant to not wear one, some are jubilant to discard masks, and others are in the middle depending upon the situation. Please be kind to one another as we navigate this new normal.

### **Employee Vaccination Survey**

Thank you for the overwhelmingly positive response to the survey so far. To date, we have 208 responses, with 93% of respondents fully vaccinated!

If you have not done so already, please take a few moments to complete the following anonymous, three-question survey to help us gauge further progress toward herd immunity for our employee base, as well as inform PPE, testing, and other supply purchases. This significantly aids our summer planning work for the upcoming semester, and a similar survey has already proven beneficial to fellow campuses in the State University system.

In partnership with Curative Medical Associates, a COVID-19 vaccination clinic utilizing the Pfizer-BioNTECH vaccine will be hosted on campus:

The Pfizer-BioNTech vaccine has been approved for emergency use in those ages 12 and under. For a minor to be vaccinated, a guardian must either be present at the clinic or complete an electronic consent form.

### **Student Vaccination Requirement**

MCLA will require undergraduate and graduate students who are attending in-person classes, conducting research on campus, living in residence halls, and participating in college sponsored activities to become fully vaccinated prior to the start of the academic year in September 2021. Medical and religious exemptions with the proper accompanying documentation will be reviewed accordingly. Students must submit a photo image/copy of their COVID-19 Vaccination Record Card, with name, DOB, and MCLA A# to Health Services at HealthServices@mcla.edu by August 1, 2021.
